

Notes on Contributors

TOM BROWN is a historic sites planner, Parks Canada, Prairie Region, and is completing his doctoral thesis on the Toronto Asylum in the nineteenth century.

NEIL CHESHIRE is a Clinical Psychologist at the University of Wales at Bangor and co-author with David Quinn of *The New Found Land of Stephen Parmenius* (1972). He has contributed several translations to the latter's five volume work *New American World* (1979). Tony Waldron is Senior Lecturer in Occupational Medicine, London School of Hygiene and Tropical Medicine and is a world authority on lead poisoning. Alison Quinn is an indexer and indefatigable research contributor to the writings of David Quinn.

BARBARA CRAIG is in charge of health related records at the Archives of Ontario. She is a frequent contributor to the pages of *Archivaria* and is currently chairing a committee of the Association of Canadian Archivists investigating the extent and state of hospital records in Canada.

HEATHER MacDOUGALL is a Course Instructor at Innis College, University of Toronto, and is currently finishing her doctoral thesis on the evolution of public health services in Toronto between 1834-1890.

CHARLES ROLAND was chairman of the department of Biomedical Communications at the Mayo Clinic prior to becoming the Hannah Professor of the History of Medicine, McMaster University. He is co-author with Paul Potter of *An Annotated Bibliography of Canadian Medical Periodicals, 1826-1975* (1979) and is preparing a bibliography of the history of medicine in Canada.

JANICE SANDOMIRSKY is a postgraduate of York University. She holds an M.A. in Canadian History and has a special interest in photographic records.

JOAN SHERWOOD is researching medical practices relating to the newborn and is currently an Instructor at Queen's University, Department of History. She was awarded her doctorate at the University of Toronto in 1979 for her study of abandoned and illegitimate infants in eighteenth century Spain.

SAMUEL SHORTT is Hannah Professor of the History of Medicine at Queen's University and is author of *The Search for an Ideal: Six Canadian Intellectuals and their convictions in an age of transition, 1890-1930* (1976). He is preparing a volume of readings in Canadian medical history.

ROSALIE STOTT is at the Economic History department, University of Edinburgh, and is writing a doctoral thesis on the Edinburgh Medical School in the eighteenth century.

JIM WHALEN has worked extensively on Poor Law policy in nineteenth century New Brunswick. He works as an archivist in the State and Military Records section of the Federal Archives Division, Public Archives of Canada.
