

## *Our Contributors*

**F. Dolores Donnelly** was professor in the Faculty of Library and Information Science, University of Toronto, from 1971 until 1982 when she became Professor Emeritus. She is the author of *The National Library of Canada* (1973) and of several studies and chapters of books dealing with national library trends and services. She is currently engaged in lecturing and research; her most recent work involves a study of the British library system.

**Gwynneth Evans** was head of the Reference and Bibliography Section of the National Library from 1975 to 1980 and of the Public Services Section of the National Museums Library, before being appointed Executive Secretary of the National Library.

**Elizabeth Hawkins** joined the staff of the National Library in 1965. She has held a number of posts including Chief of the Canadiana Acquisitions Division and Legal Deposit Office, 1966-73, Information Coordinator, Cataloguing Branch, 1973-76, and Special Projects Officer, Research and Planning Branch, 1976-77, and Office of the National Librarian, 1977 to present.

**Joan Honeywell** was a member of the Reference and Bibliography Section of the National Library from 1974 to 1979, and since then has been Vancouver Court House Librarian.

**Alice Jean Lunn** was the first Editor of *Canadiana*, the national bibliography of Canada; Director of the Cataloguing Branch; and subsequently Director of the Office of Library Standards, in the National Library of Canada, 1950-1975. During her long career, she has contributed articles and conference papers in the fields of librarianship, history, and bibliography.

**William Ormsby** is presently the Provincial Archivist of Ontario, a position he has held since July 1978. He began his archival career at the Public Archives of Canada in 1948 and continued at the PAC under Dr. Lamb until 1964, when he accepted a teaching position at Brock University where he remained until 1978.

**Bruce Peel** was Chief Librarian, University of Alberta, from 1955 until his retirement last year; he is the author of numerous books, articles, and bibliographies in library science and regional history.

**J.W. Pickersgill** has enjoyed a long career as a civil servant and political figure in Ottawa. From 1937 until 1952, he served in various capacities in the Prime Minister's Office under W.L.M. King and Louis St. Laurent. In 1953 he entered politics and was elected to the House of Commons six times between 1953 and 1965. During his parliamentary career, he held various Cabinet posts. He is the author of several books of memoirs and is still a frequent visitor to the PAC.

**Peter Robertson** is an archivist with the National Photography Collection, PAC, and has contributed to *Archivaria* on a number of occasions.

**Wilfred I. Smith** joined the Public Archives of Canada in 1950 and in 1970 succeeded Dr. Lamb as Dominion Archivist. He is a frequent contributor to professional archival journals in several countries and has served as a member of various national and international archival organizations.

**Michael Swift** held various positions with the Public Archives of Canada between 1964 and 1971 when he was appointed Provincial Archivist of New Brunswick; he remained there until he returned to the PAC as Director General of the Archives Branch in 1978, a position he still holds.

**Guy Sylvestre** is National Librarian, a position he has held since 1968 when he succeeded Dr. Lamb. Previous to this appointment, he was Associate Parliamentary Librarian, 1956-1968. He is the author of several books and articles on Canadian literature and poetry and, of course, in the field of librarianship.

**Thomas H.B. Symons**, the Vanier Professor at Trent University, is a teacher and writer in the field of Canadian studies; he is the author of *To Know Ourselves* (1975) and, more recently, he served as a member of the Applebaum-Hébert Committee to review federal cultural policy.

**Hugh A. Taylor** has been Provincial Archivist of Alberta, 1966-1968, New Brunswick, 1968-1971, and Nova Scotia, 1978-1982; from 1971 until 1978 he was Director of the Archives Branch, Public Archives of Canada. He has published numerous articles on archives and archival practice and, most recently, has been teaching archival studies at the University of British Columbia.

**Ian E. Wilson** is Provincial Archivist of Saskatchewan and serves as Chairman of the Saskatchewan Heritage Advisory Board. He was also Chairman of the Consultative Group on Archives whose report, *Canadian Archives*, was published by the Social Sciences and Humanities Research Council in 1980. Prior to assuming his present duties in 1976, he was University Archivist at Queen's University, Kingston.

**Glenn T. Wright** is an archivist in the Federal Archives Division, PAC, currently working on the implementation of access and privacy legislation in the Public Archives. This issue of the journal marks his return to the *Archivaria* masthead after an absence of six years.
