Richard C. Berner is University Archivist and Head of the Archives and Manuscripts Division at the University of Washington Libraries, Seattle. His *Archival Theory and Practice in the United States: A Historical Analysis* (1983) has been widely acclaimed. He has taught many archival courses, held numerous positions in archival and library organizations, and published more than thirty articles, especially concerning archival arrangement, description, and provenance.

George Bolotenko is an archivist in the Manuscript Division, Public Archives of Canada. His "Archivists and Historians: Keepers of the Well" in *Archivaria* 16 sparked numerous responses in the next issue, to which his present piece is the reply. Dr. Bolotenko taught history before coming to the PAC in early 1981.

Kenneth L. Chasse is Director of Research for the Ontario Legal Aid Plan. Called to the bar in Ontario in 1966 and in British Columbia in 1978, he was a Crown prosecutor in Toronto until 1976, a special advisor to the federal Department of Justice until 1978, a teacher at various Faculties of Law, and a member and first chairman of the Federal-Provincial Task Force on Uniform Rules of Evidence.

Kathleen Garay has a doctorate in legal history from the University of Toronto. She is a part-time Assistant Professor of History and a full-time archivist at McMaster University and has worked with archival collections in England and Eastern Europe.

Ray Grover is the Director of the New Zealand National Archives. His historical narrative, *Cork of War*, won the N.Z. National Book Award for non-fiction in 1983. He has also published a novel, a bibliography of New Zealand in the Clio Press World Bibliographical Series (which also won an award), and periodical articles on archives, library, literary, and historical matters.

Kathy Hall received an M.A. in Canadian history from the University of Western Ontario in 1979 and joined the Manuscript Division, Public Archives of Canada, two years later.

Robert Hayward has worked in cartographic and federal government records since joining the Public Archives of Canada in 1972. From September 1982 he has been charged with implementing the federal access and privacy legislation within the Public Archives and is now Chief, Access Section, Federal Archives Division.

Mark Hopkins has worked in private and government records since joining the Public Archives of Canada in 1974. He is now Chief, Reference and Information Processing Section, Federal Archives Division, and has previously contributed to *Archivaria*.

Jim Keon joined the Department of Consumer and Corporate Affairs in 1978 as a copyright analyst and is now senior policy advisor on intellectual and industrial property. He has authored three reports in the Department's Copyright Revision Studies series.

Louis Knafla is with the Department of History, University of Calgary, where he teaches courses in the history of Canadian and English law. He also teaches in the Faculty of Law and is Coordinator of the Alberta Legal History Project. His current research interests are the history of crime and criminal justice.

David Leonard was an archivist at the Provincial Archives of Alberta, 1969-71, and at the City of Edmonton Archives, 1976-78. From 1978 to 1981, he was Archivist of the Northwest Territories. Dr. Leonard is now Senior Archivist for Government Records at the Provincial Archives of Alberta and a member of the ACA Executive.

Jerry O'Brien joined the Public Archives of Canada in 1968. Since 1973 he has been Chief of State and Military Records, Federal Archives Division.

Peter N. Oliver is a Professor of History, York University, Associate Editor of the Ontario Historical Studies series, and Editor-in-Chief of The Osgoode Society. He is working on a "History of Corrections in Ontario."

Frits Pannekoek is Director of the Historic Sites Service of the Province of Alberta and Editor-in-Chief of *Prairie Forum*. He is the author of numerous articles on the Red River settlement and the nineteenth-century Canadian West.

Roy Schaeffer graduated in history from the University of Toronto and served as records and archives consultant to the Law Society of Upper Canada in the summer of 1982. He has been archivist there since September 1983.

C.J. Shepard is an archivist in the Government Records Section at the Archives of Ontario, who has published other pieces on archives and legal records.

Robin Skelton, born in Yorkshire, has taught at the University of Victoria since 1963, where he was co-founder of the *Malahat Review* and its joint and later (1967-83) sole editor. He was partly responsible for the creation of the Special Collections section of the MacPherson Library and edited the *Works* of J.M. Sygne for Oxford University Press. He is the author or compiler of over seventy books and chapbooks.

Shelley Sweeney was recently appointed University Archivist for the University of Regina. She is also completing her Masters of Archival Studies degree at the University of British Columbia.

Hugh Taylor was Provincial Archivist of Alberta, New Brunswick, and Nova Scotia successively, and Director of the Archives Branch at the Public Archives of Canada. He is now retired, works as a consulting archivist, and teaches part-time in the Master of Archival Studies programme at UBC. He was granted the rare honour of

an Honorary Life Membership in the Association of Canadian Archivists in June 1983. He has published numerous articles on archival theory and practice; his early training and experience was in England.

Jean Tener is an archivist in the Rare Books and Special Collections Department, University of Calgary Library. She wrote on access and archives in *Archivaria* 6 and has served on the ACA Executive.

David Walden is the Chief of the Social/Cultural Archives of the Manuscript Division, Public Archives of Canada, the Administrator of the National Archival Appraisal Board, and a former Coordinator of the PAC's Archival Appraisal Service.

James Whalen is an archivist in the Federal Archives Division, Public Archives of Canada, where he has been responsible for legal records for ten years. He has written several articles on social welfare in nineteenth-century New Brunswick. He joined the PAC in 1968 after receiving his M.A. from the University of New Brunswick.

Doug Whyte is an archivist in the Federal Archives Division of the Public Archives of Canada. He worked before in Prime Ministers' Archives, Manuscript Division, and from 1981 to 1984 was responsible for the Diefenbaker Project.

Karyl Winn has been Curator of Manuscripts at the University of Washington Library in Seattle since 1970. She is a member of the Society of American Archivists' Copyright Task Force.
