Jim Burant is Chief, Collections Management, in the Picture Division, Public Archives of Canada. In addition to several articles, he has published *Friendly Spies on the Northern Tour, 1815-1837* and *The Garrison Years: London, Canada West, 1793-1853*.

Terry Cook is Chief, Social Affairs and Natural Resources Records, at the Public Archives of Canada. After various junior editorial stints with *Archivaria*, he was General Editor of the journal from 1982 to 1984. He also edited the Canadian Historical Association's *Historical Papers* for four years and since 1982 has been Editor of the CHA's Historical Booklet series. In addition to eight PAC guides and inventories, Dr. Cook has published several articles in both Canadian social and intellectual history and in archival theory and practice.

Richard Cox obtained an M.A. from the University of Maryland in 1978 with a thesis on the development of archives in Maryland from 1634 to 1934. He has been Archivist and Records Manager for the Baltimore City Archives and is now Head, Archives and Records Division, Alabama Department of Archives and History.

Patrick A. Dunae earned a Ph.D. at Manchester University and taught history at the University of Victoria. He is now an archivist in the Manuscripts and Government Records Division, Provincial Archives of British Columbia. He is the author of a book and several articles on nineteenth-century immigration and imperialism.

Carolyn Gray is a doctoral student in the History Department at McMaster University. Her article in this issue is taken from her forthcoming dissertation entitled "Sir John Gibson and his 'Electric City': Class Dynamics and Urban Development in Hamilton, Ontario, 1842-1929."

Josef Henke is the archivist responsible for Nazi party records in the Archives of the Federal Republic of Germany. He has been an archivist in the Federal Archives since 1971. His doctorate in German history was received from the University of Freiburg in 1972.

Richard Kesner is Manager of Office Systems and Services for the F.W. Faxon Company of Westwood, Massachusetts. Before accepting his current position, he was Director of the Archives of Appalachia. He has made numerous contri-

butions to archival, historical, and records management journals. His most recent monographs are *Microcomputer Applications in Libraries: A Management Tool for the 1980's* and *Automating Archival and Records Administration: Planning and Implementation Strategies*. He received a doctorate in history from Stanford University in 1977.

Graham Lowe earned a Ph.D. at the University of Toronto in 1979 for a dissertation on the history of office work in the early twentieth century. He is an Associate Professor in the Department of Sociology at the University of Alberta.

David Mattison is an archivist in the Sound and Moving Image Division of the Provincial Archives of British Columbia and the word-processing coordinator for the Archives. He was formerly the librarian of Columbia College in Vancouver. His work on the history of photography has appeared in *B.C. Studies* and *History of Photography*.

John Meisel is Sir Edward Peacock Professor of Political Science at Queen's University. From 1980 to 1983, he was on leave from the Department of Political Studies at Queen's to serve as Chairman of the Canadian Radio-television and Telecommunications Commission.

Tom Nesmith is General Editor of *Archivaria* and, since April 1982, has been an archivist in the Social Affairs and Natural Resources Records Section in the Federal Archives Division of the PAC. Between November 1978 and April 1982, he was an archivist in the Manuscript Division of the PAC. His article in this issue was adapted from work in progress for a dissertation on the Ontario Agricultural College.

Bill Russell has been an archivist in the Social Affairs and Natural Resources Records Section of the Federal Archives Division of the PAC since 1982. He worked previously as an archivist in the Manuscript Division of the PAC. His interest in native studies and the role of the Department of Indian and Northern Affairs stems from his experience as a treaty rights researcher with the Indian Association of Alberta, 1978 to 1980.
