Jim Burant is Chief, Collections Management, in the Picture Division, Public Archives of Canada. In addition to several articles, he has published *Friendly Spies on the Northern Tour, 1815-1837* and *The Garrison Years: London, Canada West, 1793-1853*.

Terry Cook is Chief, Social Affairs and Natural Resources Records, at the Public Archives of Canada. After various junior editorial stints with *Archivaria*, he was General Editor of the journal from 1982 to 1984. He also edited the Canadian Historical Association's *Historical Papers* for four years and since 1982 has been Editor of the CHA's Historical Booklet series. In addition to eight PAC guides and inventories, Dr. Cook has published several articles in both Canadian social and intellectual history and in archival theory and practice.

Alexis Delvaux, Susan Dupuis, and Lise Perron-Croteau are on the staff of the Public Archives Library.

Lyle Dick is an agricultural and settlement historian with Parks Canada's Prairie and Northern Region in Winnipeg, and has authored several ornery critiques of Canadian historical writing. He is a member of the National Archival Appraisal Board.

Sue Gavrel is the Chief, Documentation and Public Service Section, Machine-Readable Archives Division, PAC.

Lawrence D. Geller is National Endowment for the Humanities Archivist of Hadassah: The Women's Zionist Organization of America. He served from 1969 until 1982 as Director of the Pilgrim Society and Archivist of Plymouth, Massachusetts. Holder of a Ph.D. from Roosevelt University, he has written five books and numerous pamphlets and articles on historical and archival themes.

Christopher L. Hives is a graduate of the Master of Archival Studies programme at the University of British Columbia. He is also an archivist in Special Collections, the University of British Columbia Library.

H.T. Holman is a former Assistant Provincial Archivist for Prince Edward Island. He is now an Access to Information Officer with the Department of Indian and Northern Affairs.

Edward W. Laine has a Ph.D. in history from McGill University. For the last twelve years he has been the archivist responsible for Finnish-Canadian material in the National Ethnic Archives Section, Manuscript Division, PAC. He has written widely on the history of the Finnish-Canadian community and was editor of *Scandinavian-Canadian Studies* 1982-85.

Anne MacDermaid has been University Archivist for Queen's University and Archivist of the City of Kingston since 1977. She is a past president of the ACA (1982-83). She has been a member of the SSHRCC committee on archives (1983-85) and the SSHRCC Working Group on Archival Descriptive Standards (1983-86) and is presently a member of the SSHRCC Research Tools Adjudication Committee and the Ontario representative on the Canadian Council of Archives.

Wilma MacDonald is an archivist in the Political and Public Affairs Section of the Manuscript Division, PAC. She has also worked in the Pre-Confederation and Social and Cultural Archives Sections of the division. Prior to joining the PAC staff, she worked for Anglican Church archives in Vancouver and Winnipeg. She was in the first class of the Master of Archival Studies programme at the University of British Columbia, 1981-83.

Don Macleod received a Ph.D. from the University of Toronto with a thesis on collective influences on nineteenth-century Nova Scotia mining technology. He is an archivist in the Government Records Section, Archives of Ontario. His previous articles have appeared in *Acadiensis*, the Canadian Historical Association's *Historical Papers*, and *Archivaria*.

John Mallinson is a physicist and Director of the Center for Magnetic Recording Research at the University of California in San Diego.

Judith Roberts-Moore has been an archivist at the Public Archives of Canada since 1980.
