**Gabrielle Blais** is Director, Reference and Researcher Services Division, Public Programs Branch, National Archives of Canada. She was previously Acting Chief of the Access Section and an archivist in the Social Affairs and Natural Resources Records Section of the Government Archives Division. In addition to serving as the Book Review Editor for *Archivaria* (1986-89), Ms. Blais is the Co-Editor of the Canadian Historical Association's Booklet Series, a member of the Editorial Board of *Archivaria*, and Chair of the Standing Committee on Public Awareness and Advocacy of the ACA.

**Helen D. Burgess** graduated from the University of Lethbridge with an honours B.A. in chemistry. She went on to obtain an M.Sc. in protein chemistry from the University of British Columbia and a Masters of Conservation from Queen's University, specializing in conservation science. In 1978 she joined the staff of Conservation Processes Research at CCI, where she is currently employed as Senior Conservation Scientist.

**Michael Cook** is University Archivist, and director of the Archival Description Project, University of Liverpool, England. Among other adventures, he was once Director of the National Archives of Tanzania (1964-66) and of the archival training course for English-speaking Africa at the University of Ghana (1975-77). A strong interest in international affairs continued when he served as Chair of the International Council on Archives' Education and Training Committee (1984-88); he is a corresponding member of the ICA's Automation Committee, and was several times a consultant for Unesco in archival development. Since the setting up of the Archival Description Project in 1984, he has concentrated on establishing standards for description and data exchange, which has brought him into close contact with many Canadian colleagues. The *Manual of Archival Description* (2nd edition, with Margaret Procter), *Archive Administration* (1977), *Archives and the Computer* (1980, 1986), and *The Management of Information From Archives* (1986) are some of his previous publications.

**Terry Cook** is Chief of the Social Affairs and Natural Resources Records Section, Government Archives Division, National Archives of Canada. He was Editor of the Canadian Historical Association's *Historical Papers* (1978-82) and since 1982 has been Co-Editor of its Historical Booklets series. A General Editor of *Archivaria* (1982-84), he remains on its Editorial Board, as well as on that for the Society of American Archivists. He has been a member of the ACA's Programme Committee three times, including the 1991 conference, and is on the SAA's Programme Committee for 1992. The author of numerous studies in Canadian social and intellectual history and in archival theory and practice, his most recent projects include a RAMP study for the International Council on Archives concerning *The Archival Appraisal of Records Containing Personal Information* and a booklet for the Bureau of Canadian Archivists' Planning Committee on Descriptive Standards entitled *The Concept of the Archival Fonds: A Discussion Paper*.

**Barbara L. Craig** became the Archivist of York University, Toronto, in January 1989. She was previously the archivist responsible for records of the provincial Ministry of

Health, including the records of public general hospitals. In 1989 she completed a degree in the Doctorate Programme of the School of Library, Archive and Information Studies, University of London, England, where her dissertation was entitled "Hospital Records in London, England and the Province of Ontario, Canada, 1880 to 1950." She is a past president of the Association of Canadian Archivists (1983-84), currently Chair of the Publications Committee of the ACA, Chair of the Ontario Council of Archives, and also a fellow of the Founders College at York University.

**Elizabeth Diamond** is the archivist of the Diefenbaker Centre at the University of Saskatchewan. She completed the archives course at the Bodleian Library in Oxford in 1973. Since then she has worked on archival projects in Oxford, Kenya and Ottawa. She was Vice-President of the Saskatchewan Archivists' Society in 1989-90 and is currently Chair of the ACA Membership Committee.

**Wendy Duff**, presently an Instructor on the faculty of the Nova Scotia Community College, co-authored the *Nova Scotia Subject Headings Authority* while a member of the staff of the Public Archives of Nova Scotia. She is an ACA member of the Bureau of Canadian Archivists' Planning Committee on Descriptive Standards, and a member of the Subject Indexing Working Group. She is also a member of the International Council on Archives' Ad Hoc Commission on Descriptive Standards.

**Stephen Duffy** is a graduate of the honours chemistry programme at Laurentian University. He obtained his Master's degree in analytical chemistry in 1988 from Queen's University in Kingston. He spent one year in industrial chemistry before starting research on paper conservation for the Canadian Council of Archives in conjunction with the Canadian Conservation Institute.

**Allan C. Dunlop** is Associate Provincial Archivist of Nova Scotia. He has researched and written extensively about the people and history of Pictou County.

**Luciana Duranti** is Assistant Professor in the Master of Archival Studies Programme at the School of Library, Archival and Information Studies, University of British Columbia, Vancouver, a position she has held since 1 July 1987. Prior to this, she was a Professor in the Special School of Archivists and Librarians at the University of Rome (1982-1987); served as State Archivist in the State Archives of Rome (1978-1982); and Project Archivist for the National Research Council of Italy (1974-1977). Professor Duranti has earned a Doctorate in Arts (1973) and a Master of Archival Studies (1975), both degrees from the University of Rome. In addition to teaching three courses in the M.A.S. programme, she is active in several archival and records management associations, and her writings have been published internationally.

**David Enns** is Chief of Reference Services at the National Archives of Canada, a position he has held since April 1988. He previously worked in the Manuscript Division of the same institution. He received a B.A. (Hons.) degree from the University of Winnipeg in 1980 and an M.A., with a specialization in education and labour history, from Dalhousie University in 1982.

**Timothy L. Ericson** is currently Director of the Milwaukee Urban Archives at the University of Wisconsin-Milwaukee, a position he has held since July 1989. Prior to this he was Education Officer of the Society of American Archivists (1987-1989), the University Archivist and Area Research Center Director at the University of Wisconsin-River Falls (1977-1987), and for two years a project archivist and map curator at the

State Historical Society of Wisconsin. He received an M.A. in American history from UW-River Falls and an M.L.S. from the University of Wisconsin-Madison.

**Kent Haworth**, formerly Director, Records Management Branch, for the government of British Columbia and University Archivist at the University of Toronto, is currently Acting Head of the Public Records Division at the Public Archives of Nova Scotia, where he has been employed since 1989. He has been an ACA representative on the Bureau of Canadian Archivists' Planning Committee on Descriptive Standards since 1986, and became Chair of the PCDS in 1989.

**Sandra Haycock** has been employed for twelve years at the Public Archives of Nova Scotia, where until recently she was Head of the Public Records Division. She is currently on a one-year secondment as Special Projects Archivist. She is also Editor of the Council of Nova Scotia Archives *Newsletter*, and Regional Editor of *Archivaria* for the Maritimes and Newfoundland.

**Lawrence Klippenstein** is the historian/archivist of the Mennonite Heritage Centre in Winnipeg. He received his Ph.D. in Russian history from the University of Minnesota. In addition to teaching history at the Canadian Mennonite Bible College, he is editor of the quarterly newsletter, *The Mennonite Historian*, President of the Manitoba Council of Archives, and President of the Manitoba Mennonite Historical Society.

**Dianne Reid** received a B.A. in History from the University of Toronto and an M.A. from Carleton University. After working in the Manuscript Division of the Public Archives of Canada, she moved on to the Diefenbaker Project from 1981 to 1989, where she was acting head of the project in 1986. She has contributed many reviews to *Archivaria* and is currently the Exhibitions Review Editor.

**Guy St-Denis** is the Assistant to the Librarian-in-Charge of the Regional Collection, D.B. Weldon Library at the University of Western Ontario. A part-time history student, he is also the First Vice-President of the London and Middlesex Historical Society and the editor of its new publication, *The Historian*.
