Catherine Bailey is the archivist responsible for health and welfare records in the Government Archives Division of the National Archives of Canada, a position she has held since August 1988. She holds an Honours B.A. in Canadian History (1986) and a Master of Archival Studies degree (1988) from the University of British Columbia. A founding member of the Association of Canadian Archivists' Special Interest Section on Electronic Records (SISER), she presently serves as its Secretary-Treasurer. She is Co-Editor of the ACA's Web Site, a member of the Advisory Board for the Archives Technician Programme of Algonquin College, and a member of the Canadian Council on Archives' Standards Committee.

Terry Cook will join the faculty of the Archival Studies Programme at the University of Manitoba in 1998 on a part-time basis, as well as undertake archival consulting and freelance writing. He leaves the National Archives of Canada after twenty-three years, for the last five as Director of the Records Disposition Division, with responsibility for the appraisal and disposal of all records in all media for the Government of Canada. A former General Editor of *Archivaria* (1982-84), he was also Editor of the Canadian Historical Association's *Historical Papers* (1978-82) and of its Historical Booklets series (1982-94). His publications focus on the historical evolution of records, "total archives," the fonds concept, the history of archives, electronic records, and especially appraisal, including a book in the ICA's RAMP series, as well as on themes in Canadian social and intellectual history. He has presented workshops and seminars on electronic records, appraisal, and archival ethics across Canada and around the world, including extended invitational tours of Australia and (twice) South Africa, lectures in England and Brazil, and a plenary address to the ICA in Beijing. He is a Fellow of the Society of American Archivists and the Society of Canadian Office Automation Professionals, and has received a special Merit Award from the Canadian Historical Association and the South African Society of Archivists Prize. And he still searches for the ghost of Elvis.

Barbara Craig is Associate Professor of archive studies and Director of the Centre for Research in Information Studies in the Faculty of Information Studies at the University of Toronto. Prior to her appointment in August 1993, she was the Archivist of York University (North York, Ontario) and the Head of the Archives and Special Collections Department of the Scott Library from 1989, and an archivist at the Archives of Ontario from 1970. She has a Ph.D. in Archive Studies, has undertaken extensive research into hospital archives in Canada, the United States, and the United Kingdom, and has published widely on the history of record-keeping, the history of medicine and medical archives, and archive theory. A past Chair of the Ontario Council of Archives, an officer of the Association of Canadian Archivists in many capacities, and a Director of the Ontario Women's History Network, Dr. Craig is the Chair of the Canadian Council of Archives' Preservation Committee, Reviews Editor of the *American Archivist*, and an active participant in the growing Health Archives Information Group (HAIG) in Ontario. A Canada-wide health archives information network based on a web-site and a 1-800 service is operated under her direction. Most recently she was Theme Editor of *Archivaria* 41, an issue devoted to medical archives.

Hugh Grant is Associate Professor of Economics at the University of Winnipeg. He received his Ph.D. in Economics from the University of Toronto. His previous work includes two papers on aspects of the Canadian fur trade.

Paul Marsden is a military archivist in the Government Archives Division of the National Archives of Canada. He came to the National Archives after graduating with an M.A. in History from the University of Toronto and after working on research projects at the Department of Finance and Atomic Energy of Canada Ltd. He is currently Co-Editor of the ACA Web Site and Chair of the ACA Special Interest Section on Electronic Records.

Shauna McRanor is currently working on her Master of Archival Studies thesis at the University of British Columbia. She received her B.A. in archaeology from Simon Fraser University in 1992 and continues to be involved with archaeological consulting in British Columbia. Her paper, "A Critical Analysis of Intrinsic Value," won the 1996 Theodore Calvin Pease Award of the Society of American Archivists.

M. Stephen Salmon is the business archivist in the Manuscript Division of the National Archives of Canada. He is chair of the editorial board of *The Northern Mariner/Le Marin du nord*. His most recent publication is "A Prosperous Season: Investment in Canadian Great Lakes Shipping, 1900-1914" in *A Fully Accredited Ocean* (Ann Arbor, 1997).

Jim Suderman is a portfolio archivist at the Archives of Ontario, responsible for some of the provincial central agencies, including the Premier's Office, Management Board, Cabinet Office, and the offices of the Legislative Assembly. He has held this position since 1990, prior to which he worked as an archivist in Manitoba. He holds an M.A. in History.

Hugh Taylor was Provincial Archivist of Alberta, New Brunswick, and Nova Scotia successively, and Director of the Archives Branch (a predecessor of the present Archives Development and Preservation Branch) at the Public (now National) Archives of Canada. He also served as President of the Society of American Archivists, and founding President of the Council of Nova Scotia Archives. He is now retired and works as a consulting archivist. He was granted an Honorary Life Membership in the Association of Canadian Archivists in June 1983. He has published numerous articles on archival theory and practice. A *festschrift* in his honour, *The Archival Imagination*, was published by the Association of Canadian Archivists in 1992.
