Richard Brown has been an archivist at the National Archives of Canada for sixteen years, where he presently manages the Appraisal and Special Projects Section of the Government Archives and Records Disposition Division. Before coming to the National Archives, he studied Canadian history at the University of New Brunswick and civil law at McGill University. From 1975, he spent seven years pursuing post-graduate work in medieval and early modern European history in Great Britain and Italy, including research residencies at the Warburg Institute of the University of London and the Archivio di Stato Modena. He received a Ph.D. in Italian renaissance history from the University of Edinburgh in 1982. Aside from essays and papers on the modern theory of archival appraisal, Richard has written and lectured abroad about a variety of early modern historical subjects, notably on the princely court, ritual and popular festivity, and penology in fifteenth-century Italy.

Sharon Anne Cook is Professor of Education and Director of Teacher Education in the Faculty of Education, University of Ottawa. A former secondary school history teacher and department head, she holds a doctorate in history and is the author of 'Through Sunshine and Shadow': The Woman's Christian Temperance Union, Evangelicalism, and Reform in Ontario, 1874-1930 (McGill-Queen's University Press, 1995).

Bernadine Dodge is currently University Archivist at Trent University in Peterborough, Ontario, a position she has held since 1982. She was an archivist at the Ontario Archives from 1966 to 1972. She has served on the Board of the Ontario Council of Archives and is a past President of the Association of Canadian Archivists. She has an M.A. and an Ed.D. in history and women's studies from the University of Toronto. Her research is in the area of feminist theory and women and law in nineteenth-century Ontario.

Verne Harris was with South Africa's State Archives Service for thirteen

years, and is currently a deputy director in the newly established National Archives (January 1997). He holds an M.A. in history from the University of Natal and the National Diploma in Archival Science from the Pietermarizburg Technical College. His thesis, "Land, Labour and Ideology: Government Land Policy and the Relations Between Africans and Whites on the Land in Northern Natal 1910-1936," was published in the Archives Year Book for South African History in 1991. A member of the South African Society of Archivists' National Committee since 1988, he has edited the last ten issues of the South African Archives Journal and several other publications, including A Bilingual South African List of Archival Terms and Professional Code for South African Archivists (both with Clive Kirkwood). From 1992 to 1993, he served on the African National Congress Archives Sub-committee, and chaired the Working Committee of the Consultative Forum which drafted the South Africa Bill in 1995. In 1996, he chaired the Drafting Committee of the KwaZulu-Natal Task Group which produced the Provincial Archives of KwaZulu-Natal Bill. His latest monograph, Exploring Archives: An Introduction to Archival Ideas and Practice in South Africa, was published by the National Archives of South African in 1997.

Margaret Hedstrom is an Associate Professor at the School of Information, University of Michigan, where she teaches in the areas of archives, electronic records management, and digital preservation. Before joining the faculty at Michigan in 1995, she worked for ten years at the New York State Archives and Records Administration where she was Chief of State Records Advisory Services and Director of the Center for Electronic Records. She has published widely on many aspects of archival management and electronic records and is currently writing a book on digital preservation. Her current research interests include digital preservation strategies, the impact of electronic communications on organizational memory and documentation, and remote access to archival material. She is a fellow of the Society of American Archivists and was the first recipient of the annual Award for Excellence in New York State Government Information Services.

Tim Hutchinson is currently working as a contract archivist at the University of Saskatchewan Archives. He recently completed a Master's of Information (Archives and Records Management) degree at the University of Michigan, and was previously a summer student at the United Church Archives in Toronto. He has an undergraduate degree from McMaster University's Arts and Science Programme, and an M.A. in mathematics from Queen's University.

Eric Ketelaar is Professor of Archival Science both at Leiden University and at the University of Amsterdam, and Inspector General of the State

Archives Service of The Netherlands. He was General State Archivist (National Archivist) of The Netherlands from 1989 to 1997. Previously, he was Assistant Lecturer of Legal History at Leiden University, Secretary of the Archives Council, Director of the Dutch State School of Archivists, and Assistant to the General State Archivist, Deputy General State Archivist, and State Archivist in the province of Groningen. He has served the Royal Society of Dutch Archivists as Vice President, President, and Chairman of the Steering Committee on Automation. For his work as editor of the thirteen-volume series of guides to all repositories in The Netherlands (1979-1987), he was awarded the Society of Dutch Archivists' first Hendrik van Wijn medal. He has served the International Council of Archives as Secretary for Standardization, and as Secretary of the International Conference of the Round Table on archives. He has been a member of the European Commission on Preservation and Access since its foundation in 1994, and in 1996 he was elected Chairman of the Program Management Commission and Vice President of the International Council on Archives. He has written many articles (a number of which were republished in a volume of collected essays, The Archival Image, in 1997) and he has written or co-authored several books, including two general introductions to archival research and a handbook on Dutch archives and records management legislation.
