George Bolotenko received his Ph.D. in Russian and European history from the University of Toronto in 1979. After teaching there and at the Ryerson Polytechnical Institute, he joined the Manuscript Division of the Public Archives of Canada in early 1981.

Carman V. Carroll is Chief of the Public Affairs Archives, Manuscript Division, Public Archives of Canada. He has served as Secretary on the Executives of the Association of Canadian Archivists and the Canadian Historical Association.

After studies at the *Ecole nationale des Chartes* in Paris, **Michel Duchein** took his degree in archival science in 1949 and in history in 1952. He was Head of the Technical Division of the *Direction Générale des Archives de France* from 1957 to 1978, at which time he assumed his present position of Inspector General of the Archives of France. He has been Editor-in-Chief of *Archivum* since 1968; carried out special archival assignments for UNESCO, UNO, and ICA in Africa, Asia, and Latin America; and published more than thirty articles in the archival journals of eleven countries.

Terry Eastwood is Assistant Professor and Chairman of the Master of Archival Studies Programme at the University of British Columbia. He was an archivist in the Manuscript and Government Records Division of the Provincial Archives of British Columbia for eight years prior to his present appointment in 1981.

Lawrence D. Geller is National Endowment for the Humanities Archivist of Hadassah: The Women's Zionist Organization of America. He served from 1969 until 1982 as Director of the Pilgrim Society and Archivist of Plymouth, Massachusetts. Holder of a Ph.D. from Roosevelt University, he has written five books and numerous pamphlets and articles on historical and archival themes.

Since joining the Public Archives of Canada in 1974, **Mark Hopkins** has worked in both private sector and federal government textual records. He is now Chief of the Reference and Information Processing Section, Federal Archives Division.

Allan McCullogh worked at the Public Archives of Canada from 1968 to 1972. He has since been with National Historic Parks and Sites, where he has done studies on the North-West Mounted Police, transportation costs and commodity prices in Western Canada, and money and exchange in Canada.

Brian S. Osborne is a Professor and Chairman of the Department of Geography, Queen's University, Kingston. He is writing a book on the historical geography of the settlement of Kingston and is a frequent "user" of archives.

Following graduate work in Renaissance literature, Anthony L. Rees joined the United Church of Canada Archives in 1972. He was appointed the first Archivist-Fine Arts at the City of Toronto Archives in 1975 and then Archives Supervisor in 1977. In 1981 he became the first City Archivist of Calgary. F.R. Scott is the dean of Canadian literature. He was a member of the Royal Commission on Bilingualism and Biculturalism.
