Tom Belton has a Master of Arts degree in Public History from the University of Waterloo (1988). He has worked as an archivist for twenty-two years, thirteen at the Archives of Ontario working primarily with health and justice sector records, and three as Ontario's Archives Advisor. Since 2005, Tom has worked as an archivist at the University of Western Ontario Archives. His responsibilities include university records and private records relating to the legal sector. He is a Certified Archivist (Academy of Certified Archivists, 2005). His current research interests are the law affecting records, and the history of document types and recordkeeping. He has written several case studies on the history of official and personal records. Tom has served on a number of committees for the Archives Association of Ontario, the Association of Canadian Archivists, and the Canadian Council of Archives.

Rodney G.S. Carter is the Archivist for the St. Joseph Region of the Religious Hospitallers of St. Joseph, based in Kingston, Ontario. He received an Honours BA in Art History from Queen's University in 2002 and a Masters degree in Information Studies (Archival Stream), from the University of Toronto in 2005. He has served on a number of committees and special interest sections of the Association of Canadian Archivists and is currently the Vice-President of the ACA.

Jean Dryden is a member of the faculty of the College of Information Studies at the University of Maryland (<http://www.ischool.umd.edu/people/dryden/>). Her doctoral dissertation, completed at the University of Toronto in 2008, investigated the copyright practices of Canadian archival repositories in making their holdings available on the Internet. Her expertise in copyright has been developed over many years of experience as an archivist working at the National Archives of Canada, the Provincial Archives of Alberta, and as the Chief Archivist of the United Church of Canada/Victoria University Archives. She is the author of *Demystifying Copyright: A Researcher's Guide to Copyright in Canadian Libraries and Archives*. Her research interests include

copyright in the digital environment, information law and policy, archival arrangement and description, and digital preservation.

Donald C. Force is a PhD student in the Library, Archives, and Information studies program at the University of British Columbia. His current research interests focus on the relationship between archival science and law, specifically, the effects that the electronic discovery process and the admissibility of evidence have on archival principles and practices. He received his MLS and MIS degrees from Indiana University (Bloomington) in 2007, and his MA in history from Southern Illinois University (Carbondale) in 2004.

Victoria Lemieux is the Director of the Centre for the Investigation of Financial Electronic Records (CiFER) and an assistant professor of archival studies at the School of Library, Archival, and Information Studies at the University of British Columbia. She traces her interest in financial records to her 1999–2001 doctoral research on the information-related causes of the Jamaican Banking Crisis (University College London, 2002). Following completion of her doctoral research, Dr. Lemieux joined Credit Suisse as a vice-president in charge of global records policy management, later taking charge of aspects of IT security policy development and managing the risk and security components of the bank's 1.6 billion Swiss francs network outsourcing in 2007 (for which she received a "One Bank" award). She then went on to lead the bank's European infrastructure technology risk team. Dr. Lemieux joined UBC in July 2008 and established CiFER. In 2009 she was among ten new academics at UBC to be presented with the Peter Wall Institute's Early Career Scholar Award, which recognizes scholarly excellence and interdisciplinary research. She is the author of numerous publications. Her *Archivaria* article exploring the nature of the record won the 2001 W. Kaye Lamb Prize. Dr. Lemieux has also been a designated Certified Information Security Systems Professional since 2005.

Loryl MacDonald has been the Records Archivist at the University of Toronto Archives since 2000. She has served as Vice President of the Association of Canadian Archivists as well as President of the Archives Association of Ontario and the Toronto Area Archivists' Group. Loryl has also taught records management at the University of Toronto Faculty of Information. She holds a Bachelor of Laws and a Master of Archival Studies from the University of British Columbia.

Bruce P. Montgomery is Faculty Director of Archives at the University of Colorado at Boulder. He is the founding director of the UCB Human Rights Initiative and a founding member of the International Federation of Human Rights Centers and Archives. He has served as an analyst of classified docu-

ments for the US government, and is currently a consultant for the Institute for Defense Analysis, a Pentagon-funded think tank, to help set up a digital resource centre to make available electronic copies of captured al Qaeda, Taliban, and Saddam Hussein-era records. He is the author of three books, including *The Bush-Cheney Administration's Assault on Open Government*; *Subverting Open Government: White House Materials and Executive Branch Politics*; and his most recent, *Richard B. Cheney and the Rise of the Imperial Vice Presidency*. Articles by Montgomery have appeared in many leading journals, including *Presidential Studies Quarterly*, *Political Science Quarterly*, *Human Rights Quarterly*, *Peace Review*, *Archivaria*, *American Archivist*, and the *Washington Post*, among others.

Kathy Sinclair is a senior policy adviser at Public Records Office Victoria, the archival and records management authority of the Australian state of Victoria. In her nine years at PROV, Kathy has developed a special interest in the intersection of public recordkeeping and the law, and has developed products, training, and advice in the areas of copyright and intellectual property, evidence, privacy, and document destruction. A historian by training, and with a previous background in publishing, Kathy has also studied law with a particular eye to how the framework of legislation impacts upon, and is upheld by, the keeping of records.
